## Wp 4 Meeting Ekenäs 2012-05-23

### 1. Welcome and short presentation of participants

A question regarding technical meetings in WP4 arose – is there any such meetings in the WP?

In response to this question we have to say that we have had problems with participation and response/communication from other partners in the project. We will keep trying to have technical meetings and ask all partners in WP4 to prioritize and attend these meetings!

We had a technical meeting in Arkösund last fall (IRL), with very few partners attending.

### 2. Nature Living Plans and feasibility studies in BACES info. centers

**Söderköping** - Renovation and restoration of Edgars Place is progressing. Due to illness, it is not quite clear what has already been done and what still has to be done regarding the “Nature living plan” in Söderköping.

**Norrköping** – The Nature Living Plan is completed.

**Valdemarsvik** – The Nature Living Plan is nearly finished (presently being translated to English).

**Söderhamn** – The Nature Living Plan is completed.

**Estland** – the partner is not aware that this was supposed to be done (due to changes in personnel). It is not clear if anyone is working on this or not. Recruitment – process is on going.

**Finland** – not present at the meeting

CAB Östergötland will distribute the “layout” document (for the Nature Living Plan) to all partners in WP4 after this meeting. CAB will make sure it is OK to combine all partial reports to one “Nature Living Plan”.

Those partners who has done a lot of work with guiding's etc. could perhaps enhance this part of the report.

### 3. Exhibitions

The content of the exhibitions may vary, it is up to each partner to decide what to include in their exhibition.

Söderköping has no budget for realizing the exhibition within WP4. Activities connected with the exhibition are going on in both WP3 and 4. The activities in WP4 are mostly planning. There are plans for a "traditional field" (allmogeåker), where all crops and all management is done according to old tradition.

In Norrköping, work with the islands Kopparholmarna (natural reserve) and the exhibition in Isola Bella house is progressing.

In Söderhamn work with information-signs on the recycling-stations is progressing. It is supposed to be different signs on each station, depending on where in the archipelago it is situated.

### 4. GIS-maps

It seems like a good idea to put information from WP4 on the interactive map too (even though it is not included in the description of WP4 in the project application). Examples on suitable information could be the underwater films and sites from the guide-book. If there is any information that the other partners would like to include in the map, **please let CAB Östergötland know this as soon as possible – preferably before the meeting in Söderköping in September!**

### 5. Webb-site

For the project website, - what could WP4 contribute with?

On the website, we should publish all information from WP4 that could be of interest for the project. It is important that we show that we are active and produce things within the project!

### 6. Other questions and conclusions

The participants in the meeting expressed a wish for more regular meetings over the phone! It was suggested that we should have a short phone-meeting after the distribution of these minutes.

It was also suggested that we should have a short meeting for example every Friday morning at 10-11 o'clock. Sometimes you can participate and sometimes not, sometimes we have something to discuss and sometimes not – the point is the regularity! Minutes are kept and distributed to all partners in WP4 after the meeting – both to those who attended and to those that didn't.

About the information in the guidebook – the idea is that all partners will be introduced with a short presentation – it has been difficult to get the information for these texts from the partners. CAB Östergötland now suggests that they write a text that each partner can comment on, before it is added to the book!
